- Was SUBJECT promoted while with your company? No, he did not pass the probation period.

• Did you evaluate SUBJECT's performance? Can you speak to his strong and weak points? What was noted as needing improvement during this performance review? He grossly misrepresented his experience and abilities, which became very clear once we realized he was not able to perform the tasks assigned to him. It was not an issue of improvement, it was an issue of being the wrong person for the job.
